CONFIRMING YOUR 2023 CADILLAC LYRIQ PRE-ORDER

The purpose of this document is to encourage communication between customers and their dealer regarding the configuration and price of the 2023 LYRIQ, prior to placing a vehicle order. This document is not an order and does not guarantee a vehicle within any particular time-frame; an order must be placed by the dealer in order work bench.

The dealer must abide by General Motors Transactional Integrity Policy and is responsible for ensuring compliance with all laws, regulations, and licensing requirements. Although Cadillac does not require a completed Purchase Order at this time, certain local regulations may require one to be completed.

Cadillac strongly advises that customers and dealers agree on final pricing at this stage, as all final pricing for vehicle and options are negotiated and set by the selling dealer.

Please note that if customers cancel their pre-order, dealers must process a refund of the initial customer pre-order amount. Customers have the right to cancel for any reason. If the participating dealer fails to process a refund within three (3) days, participating dealer authorizes GM and/or an affiliate of GM to process the refund. Please note that, in lieu of cancellation, the customer can move their pre-order to another dealership.
